MONTHLY MARKET PERSPECTIVES

U.S. ECONOMY

- Inflation, as measured by the consumer price index (CPI), rose as expected to 2.6% on an annual basis from 2.4%.
- Retail sales rose 0.4% in October, above consensus, showing the consumer is still strong.
- Consumer sentiment rose to 71.8 in November from 70.5 in October.

U.S. EQUITY MARKETS

- The S&P 500 rallied 5.87% in November, marking its ninth gain in the last 11 months. The primary driver was the reduction in political uncertainty following Donald Trump's reelection as U.S. president. Investors expect a continuation of his first-term policies such as tax cuts, easing regulations, and tariffs, which are expected to drive economic growth and corporate profits. Financials and small cap stocks, anticipated to benefit from these policies, rallied. Optimism was further fueled by the "Magnificent Seven" companies' earnings reports, confirming the sustained growth of artificial intelligence. Over 90% of companies in the S&P 500 have reported Q3 earnings with a blended earnings growth rate of 5.9%, surpassing the initial estimate of 4.2%.
- All S&P 500 sectors were positive over the month, with consumer discretionary the best performing, up 10.16%, while healthcare was up 0.13%. Small cap stocks outperformed large caps, 11.18% versus 6.38%. Large cap growth stocks outperformed value stocks, 6.53% versus 6.03%.

INTERNATIONAL MARKETS

- The MSCI EAFE Index, representing non-U.S. developed markets, fell 0.57% in November. European markets were lower on concerns on the incoming Trump administration's trade policies and weaker economic data.
- Emerging markets, represented by the MSCI Emerging Markets Index, fell 3.59%. Chinese markets reversed some of the prior month's gains, falling 4.44%, as evidence of persistent deflation and worries about potential U.S. tariffs under incoming U.S. President Trump hurt investor confidence.

FIXED INCOME

• Yields on the 2-year and 10-year U.S. Treasury initially moved higher following the election but ultimately ended the month lower by 2 and 11 basis points (bps), respectively. Despite this decline, yields remain elevated as investors grapple with expectations of continued U.S. economic strength, higher inflation risks, and the country's fiscal trajectory. Investors also believe that rate cuts may be more gradual than initially anticipated, influenced by comments from Federal Reserve (Fed) Chairman Jerome Powell and mixed economic data on inflation and consumer strength. Traders of fed funds futures are currently pricing in a 62% probability of a 25-bp cut in December and a 38% probability that the Fed will hold rates steady.

December 2024

- The Federal Open Market Committee November minutes showed the vote to ease rates by 25 bps was unanimous. The minutes mentioned if inflation continues "to move down sustainably to 2% and the economy (remains) near maximum employment, it would likely be appropriate to move gradually toward a more neutral stance of policy over time." The minutes also noted inflation remains somewhat elevated and labor market indicators merited close monitoring.
- Investment-grade corporate spreads and high-yield spreads narrowed. The Bloomberg U.S. Aggregate Index and the Bloomberg U.S. Corporate High Yield Index rose 1.06% and 1.15%, respectively.

CURRENCY/COMMODITIES/REAL ESTATE

- West Texas Intermediate (WTI) was volatile over the month, mainly driven by geopolitical uncertainties, but ended lower at \$68.00 per barrel, on the announcement of a ceasefire between Israel and Hezbollah.
- Gold prices fell in November, closing at \$2,643.15 per oz., down 3.67%, on continued strength of the U.S. dollar and the broader, perceived implications of Donald Trump's victory on the future of fiscal policy and interest rates.
- The U.S. dollar rose in November, boosted by expectations of U.S. tariffs, closing the month at 105.74 versus 103.98 in October.

The NASDAQ Composite Index is a capitalization-weighted index that is comprised of all stocks listed on the National Association of Securities Dealers Automated Quotation System stock market, which includes both domestic and foreign companies.

The Bloomberg U.S. 1000 Total Return Index is a float market-cap-weighted benchmark of the 1,000 most highly capitalized U.S. companies.

The Bloomberg U.S. 1000 Growth Total Return Index provides exposure to companies with superior growth factor scores based on their earnings yield, valuation, dividend yield, and growth.

The Bloomberg U.S. 1000 Value Total Return Index provides exposure to companies with superior value factor scores based on their earnings yield, valuation, dividend yield, and growth.

The Bloomberg U.S. 2000 Total Return Index is a float market-cap-weighted benchmark of the lower 2,000 in capitalization of the Bloomberg U.S. 3000 Index.

The Wilshire Global REIT Index is a float-adjusted, market capitalization-weighted index that measures global publicly traded real estate investment trusts (REITs), excluding mortgage REITs, net-lease REITS, real estate finance companies, home builders, large landowners and sub-dividers, hybrid REITS, and companies that have more than 25% of their assets in direct mortgage investments.

Bloomberg Commodity Index (BCOM) is calculated on an excess return basis and reflects commodity futures price movements. The index rebalances annually weighted two-thirds by trading volume and one-third by world production, and weight-caps are applied at the commodity, sector, and group level for diversification. Roll period typically occurs from the sixth to the tenth business day based on the roll schedule.

The S&P GSCI Crude Oil Index is a sub-index of the S&P GSCI Commodity Index. The production-weighted index reflects the returns that are potentially available through an unleveraged investment in the West Texas Intermediate (WTI) crude oil futures contract.

The S&P GSCI (formerly the Goldman Sachs Commodity Index) serves as a benchmark for investment in the commodity markets and as a measure of commodity performance over time. The index was originally developed by Goldman Sachs. In 2007, ownership transferred to Standard & Poor's, which currently owns and publishes it. Futures of the S&P GSCI use a multiple of 250. The S&P GSCI contains as many commodities as possible, with rules excluding certain commodities to maintain liquidity and investability in the underlying futures markets. The index currently comprises 24 commodities from all commodity sectors.

The Wilshire Liquid Alternative IndexSM measures the collective performance of the five Wilshire Liquid Alternative strategies that make up the Wilshire Liquid Alternative Universe. The Wilshire Liquid Alternative Index (WLIQA) is designed to provide a broad measure of the liquid alternative market by combining the performance of the Wilshire Liquid Alternative Equity Hedge IndexSM (WLIQAEH), Wilshire Liquid Alternative Global Macro IndexSM (WLIQAGM), Wilshire Liquid Alternative Relative Value IndexSM (WLIQARV), Wilshire Liquid Alternative Multi-Strategy IndexSM (WLIQAMS), and Wilshire Liquid Alternative Event Driven IndexSM (WLIQAED).

It can serve as a proxy for direct real estate investing by excluding securities whose value is not always tied to the value of the underlying real estate. Exclusions include: mortgage REITs, net-lease REITs, real estate finance companies, mortgage brokers and bankers, commercial and residential real estate brokers, home builders, large landowners and sub-dividers of unimproved land, hybrid REITs and timber REITs. The rationale for the exclusions is that factors other than real estate supply and demand, such as interest rates, can influence the market value of these companies.
