# MARKET PERSPECTIVES

#### U.S. ECONOMY

- Inflation data continued to show stickiness. The consumer price index (CPI) rose from 2.7% to 2.9% on an annual basis, in line with expectations.
- The economy is estimated to have grown 2.3% in Q4 2024 (first estimate) and 2.8% in 2024, led by consumer spending and business investment.
- Retail sales rose 0.4% in December, below consensus, but control retail sales (excluding volatile sectors) were stronger than expected.

### U.S. EQUITY MARKETS

- The S&P 500 finished January with a gain of 2.78%. Markets responded positively to President Trump's initial actions and the absence of tariffs, which are expected to boost business investment and helped ease inflation fears. Strong earnings results, particularly from financials, boosted sentiment and led to a broadening of returns beyond technology stocks. The launch of a low-cost Chinese AI model, DeepSeek, triggered a selloff in semiconductor and AI-related stocks. Investors questioned the sustainability of capital expenditure plans of major AI players, given DeepSeek was developed at a fraction of the cost of comparable models.
- Ten of 11 S&P 500 sectors were positive over the month, with communication services the best performing, up 8.98%, while the information technology sector was down 2.93%. Large cap stocks outperformed small caps, 3.14% versus 2.57%. Large cap value stocks outperformed growth stocks, 4.35% versus 2.69%. S&P 500 earnings are expected to grow 12.7% year-over-year in the fourth quarter.

#### INTERNATIONAL MARKETS

- The MSCI EAFE Index, representing non-U.S. developed markets, rose 5.26% in January. European markets were higher partially on stabilization in Germany and the absence of tariffs from President Trump.
- Emerging markets, represented by the MSCI Emerging Markets Index, rose 1.79%. Chinese equities were higher on better-than-expected economic data.

# February 2025

#### **FIXED INCOME**

- Yields on the 2-year and 10-year U.S. Treasury rose to a high of 4.38% and 4.79%, before ending the month at 4.20% and 4.54%, respectively. This initial rise in yields can partially be attributed to stronger growth expectations and heightened macroeconomic uncertainty. Yields moved lower following the latest Federal Reserve (Fed) monetary policy decision.
- The Fed unanimously left the fed funds target unchanged at 4.25%-4.50%, as expected. The post-meeting statement offered a somewhat optimistic view on the labor market while dropping a key reference from the December statement that inflation "has made progress toward" the Fed's 2% inflation goal, now saying "inflation remains somewhat elevated." However, Fed Chair Powell did note the removal was a "language cleanup" and chose to shorten the statement, not to send a signal. Powell also said the central bank is no hurry to cut rates and will need to see "real progress on inflation or some weakness in the labor market before we consider making adjustments."
- Investment-grade corporate spreads and high-yield spreads narrowed. The Bloomberg U.S. Aggregate Index and the Bloomberg U.S. Corporate High Yield Index rose 0.53% and 1.37%, respectively.

## CURRENCY/COMMODITIES/REAL ESTATE

- West Texas Intermediate (WTI) rose 1.13% over the month, with prices rising
  as high as \$80.04/barrel before retreating to \$72.53 at the end of the month.
  This fall was partially driven by President Trump's executive orders, including
  the rollback on restrictions of offshore drilling.
- Gold prices rose in January, closing at \$2,798.41 per oz., up 6.63%, on the back of President Trump's tariff moves at the end of the month.
- The U.S. dollar fell against a basket of currencies on expectations that tariffs may not be implemented or done so at a slower pace than initially thought.

The S&P GSCI (formerly the Goldman Sachs Commodity Index) serves as a benchmark for investment in the commodity markets and as a measure of commodity performance over time. The index was originally developed by Goldman Sachs. In 2007, ownership transferred to Standard & Poor's, which currently owns and publishes it. Futures of the S&P GSCI use a multiple of 250. The S&P GSCI contains as many commodities as possible, with rules excluding certain commodities to maintain liquidity and investability in the underlying futures markets. The index currently comprises 24 commodities from all commodity sectors.
